I. LEGAL FRAMEWORK

Art. 1. This Regulation is drawn up in accordance with:

- a) The Higher Education Law no. 199/2023, as subsequently amended and supplemented;
- b) The Emergency Ordinance of the Government of Romania no. 194/2002 on the regime of foreigners in Romania, republished, with subsequent amendments and completions;
- c) Order of the Minister of Education no. 5655/23.07.2024 for the approval of the Methodology regarding the admission to studies of foreign citizens in university studies cycles and in postgraduate education, on places of study with the payment of tuition fees in foreign currency;
- d) Order of the Minister of Education no. 5552/16.07.2024 for the approval of the Methodology regarding the schooling conditions of Romanians abroad and foreign citizens within state, private and private confessional higher education institutions accredited in Romania;
- e) Order of the Minister of Education, National Education no. 3236/2017 on the approval of the Methodology for receiving foreign citizens for studies and schooling on places without payment of tuition fees and with scholarships and on places without payment of tuition fees, but without scholarship, in accredited state higher education institutions;
- f) Order of the Minister of Education no. 3693/2024 for the approval of the Framework Methodology on the organization of admission to higher education in short-term, bachelor's, master's and doctoral cycles;
- g) Order of the Minister of Education, Research, Youth and Sport no. 5.219/2010 regarding the recognition and equivalence of the results obtained at internationally recognized exams for the certification of language proficiency in foreign languages and at exams with European recognition for the certification of digital competences with the tests for the evaluation of language proficiency in an international language studied during high school education, respectively for the evaluation of digital competences, within the baccalaureate exam, with subsequent amendments and additions.

II. ORGANIZATION OF ADMISSION

Art. 2. In accordance with the provisions of GEO no. 194/2002 on the regime of foreigners in Romania, republished, with subsequent amendments and completions, the foreign citizen is the person who does not have Romanian citizenship, the citizenship of another member state of the European Union or of the European Economic Area or the citizenship of the Swiss Confederation.

In accordance with the legal provisions on the matter, the letter of acceptance to studies is the document issued by the Ministry of Education as proof of the acceptance to studies of the foreign citizen, in order to obtain the long-stay visa for studies.

Art. 3. In the "1 Decembrie 1918" University of Alba Iulia, foreign citizens can be admitted and schooled on places of study:

- a) without paying tuition fees, with a monthly stipend;
- b) without paying tuition fees, without monthly stipend;
- c) with the payment of tuition fees in foreign currency;
- d) within the UAB Scholarships program implemented for the promotion of study programs in English from the 3 cycles, which are in the educational offer of the University, according to art. 11 of these Regulations.

Art. 4. (1) The places of study without payment of tuition fees, with a monthly scholarship shall be granted:

- a) on a reciprocal basis, in accordance with the provisions of the bilateral cooperation documents in the field of education. These places can also be allocated in the form of scholarship months;
- b) based on unilateral offers of the Romanian state, regulated by specific normative acts;
- c) based on the offer of the Romanian state, in accordance with the legal provisions in force, at the proposal of the Ministry of Foreign Affairs (MFA), depending on Romania's external interests;
- d) based on the offer of the Romanian state, in accordance with the legal provisions in force, at the proposal of the Ministry of Economy, for the promotion of economic or commercial collaboration actions;
- e) based on the offer of the Romanian state, in accordance with the legal provisions in force, through the Ministry of Education (ME), for foreign citizens with good results in education.

(2) The study places provided for in art. 4 (1) shall be allocated for the accredited study programs, in Romanian, the full-time form of education.

Art. 5. Study places without payment of tuition fees, without monthly scholarship are granted to the following categories:

- a) members of the diplomatic corps and family members of the diplomatic corps accredited in Romania, based on a nomination of the diplomatic mission and a recommendation of the Ministry of Foreign Affairs;
- b) citizens who request or have acquired a form of protection in Romania or stateless persons whose stay on the territory of Romania is officially recognized according to the law, for the completion of the preparatory year of the Romanian language.

Art. 6. (1) The study places without payment of tuition fees, with a monthly scholarship, provided for in Article 4 letters a), b) and e) and the study places without payment of tuition fees and without scholarship, provided for in Article 5, shall be granted according to the provisions of this Regulation.

(2) The places of study without payment of tuition fees, with monthly scholarship, provided for in art. 4 letters c) and d), shall be granted through a competition of files, organized by the institutions involved, according to their own methodologies. The list of candidates and their files will be sent to the Ministry of Education by July 15 of the current year at the latest.

Art. 7. (1) Citizens of the EU and of third countries, who cumulatively meet the following conditions, may also be admitted to study places without payment of tuition fees:

- a) do not have Romanian citizenship, have not applied for or acquired a form of protection in Romania or are not stateless persons whose stay on the territory of Romania is officially recognized according to the law;
- b) they are not members of the diplomatic corps or family members of the diplomatic corps accredited in Romania;
- c) for the places of study provided for in art. 4 letters a) and b) have been nominated, through diplomatic channels, by the authorized partners;
- d) for the places of study provided for in art. 4 letters c), d) and e) have been nominated by the Ministry of Foreign Affairs, the Ministry of Economy or by the state higher education institutions, as the case may be;
- e) have not benefited from a scholarship from the Romanian state for the same cycle of studies; (submits a declaration on own responsibility in this regard) according to art. 4, para. 1, letter j of the Methodology approved by Order 5552/2024;

- f) presents study documents issued by accredited/recognized educational institutions;
- g) presents documents of studies from which it results that the studies previously carried out and their duration allow enrollment in Romania in the field and at the level of studies requested;
- h) have good results at school, respectively an average of at least 7 (seven) corresponding to the grading system in Romania or the qualification "Good", as the case may be, except for candidates for the places provided for in art. 4 letter e), who must meet one of the conditions provided for in art. 10 paragraph (4).
- i) they are not, until December 31 of the year in which they were nominated, older than 35 years old - for bachelor's and master's studies, respectively 45 years old - for doctoral studies or for postgraduate studies.
- j) **For Ukrainian citizens**, at the proposal of UAB, based on a selection process carried out at UAB level, based on its own criteria, study grants can be awarded without paying tuition fees, with a monthly scholarship from the budget of the Ministry of Education. Their admission will be made in compliance with the admission criteria for bachelor's/master's/doctoral university studies established by the UAB Senate through the Regulation on admission and schooling of Romanians from abroad within the "1 Decembrie 1918" University of Alba Iulia, in the 2026-2027 academic year. Grants are awarded by the ME according to the following procedure:
 - i. The official address of UAB to the Ministry of Education, nominating the persons proposed to receive a study grant without paying tuition fees, with a monthly scholarship from the budget of the Ministry of Education;
 - ii. The address will be accompanied by the centralizer containing the ranking of the candidates, in descending order of the results of the selection process, by study cycles;
 - iii. Information on the selection criteria applied;
 - iv. i) copy of the passport; ii) copy of the birth certificate; iii) copy of the diploma of completion of pre-university studies and the transcripts related to the years of study for upper secondary education; iv) the copy of the bachelor's degree and the diploma supplement (transcript) or the certificate showing the academic situation for all years of study, as well as the marks obtained in the bachelor's exam (for graduates of the current year) for candidates applying to continue their master's studies; v) a copy of the master's degree and the diploma supplement (transcript) or the certificate showing the school situation for all years of study for candidates applying to continue their doctoral studies, as the case may be.

(2) Ukrainian candidates who cannot prove their studies through documents issued by the educational institution they previously attended in Ukraine, shall submit to the higher education institution in Romania, before completing their studies, the diplomas that allowed them access to the study cycle in which they were enrolled.

Art. 8. (1) Foreign citizens may be enrolled in the places provided for in art. 4 letters a), b), c) and d) after graduating from the preparatory year of Romanian language, organized according to the regulations in force.

(2) The following categories of persons are exempted from the obligation to present the certificate of graduation of the preparatory year, when enrolling in study programs taught in Romanian:

- a) persons who present Romanian study documents (diplomas and certificates) or study documents, school situations attesting to at least four consecutive years of studies followed in Romanian, in an educational unit/institution in the national system in Romania;
- b) those who, in order to enroll in university education, pass the Romanian language test, organized according to the legal provisions;
- c) those who, in order to enroll in university education, present certificates of language proficiency, minimum level B1, issued according to the regulations in force.

(3) Foreign citizens may be enrolled in the places provided for in art. 5, after graduating from the preparatory year, during which they acquire the necessary knowledge of the Romanian language, or if they meet the conditions provided for in art. 8 para. (2).

(4) The members of the diplomatic corps and/or the family members of the diplomatic corps accredited in Romania may choose to follow accredited study programs with teaching in a foreign language at UAB, under a self-financed status in RON, in the amount established for Romanian students.

(5) For university studies organized in a foreign language, admission shall be held in the foreign language of teaching of the university study program, as well as Romanian students.

Art. 9. (1) The awarding of the places provided for in art. 4 letters a) and b) shall be made on the basis of an application file provided within the Study in Romania Program, managed by the Ministry of Education, at [the address https://studyinromania.gov.ro/](https://studyinromania.gov.ro/).

(2) UAB shall issue the notice of admission to the requested study program or to another study program proposed by it, as well as the opinion regarding the possibility of providing accommodation in the university dormitory.

(3) The Ministry of Education shall issue to the host university the assignment order, based on which the scholarship holder shall be enrolled in studies, after arrival in Romania.

Art. 10. The procedure for granting the places provided for in art. 4 letter e) is carried out as follows:

(1) for foreign students enrolled on places with fee in foreign currency, with outstanding academic and scientific results, UAB will submit the following documents to the ME-DGRIAE:

- a) the official address, signed by the rector of UAB, nominating the persons proposed for receiving a place of study without paying tuition fees and with a scholarship;
- b) maximum 5 application files;
- c) the centralizer containing the ranking of the candidates, in descending order of academic results.

(2) The application file shall contain:

- a) the school situation for each year of study (except the preparatory year), for candidates applying to continue their bachelor's degree studies;
- b) copy of the bachelor's degree and the diploma supplement (transcript) or certificate showing the academic situation for all years of study, as well as the marks obtained in the bachelor's exam (for graduates of the current year) for candidates who apply to continue their master's, doctoral or postgraduate studies in the field of health, as the case may be;
- c) curriculum vitae, list of scientific papers, specialized publications, reports, recommendations from at least two university professors or specialists in the field - for candidates for doctoral studies;
- d) copy of the birth certificate;
- e) copy of passport;
- f) copy of the residence permit in Romania.

(3) The application procedure shall be carried out as follows:

- a) the proposals for candidacies are established by the Senate in descending order of averages and will be brought to the attention of potential candidates, by posting them on the official website of the UAB;
- b) the nominal list of candidacy proposals will be approved by the UAB Senate and will be posted on the official website;
- c) the nominal list and the candidates' files will be submitted to the ME - DGRIAE by November 30 of each year.

(4) The following categories of students may apply for these scholarships:

- a) foreign citizens, except those who are in a final year, who have completed at least one year of studies, outside the preparatory year, full-time education, in an accredited state higher education institution and have obtained a minimum average of 7.00 and
- b) foreign citizens, graduates of a university study program in Romania, full-time education, who have obtained an overall average of at least 7.00 and who continue their studies in an accredited state higher education institution.

(5) For the evaluation of the candidacy files and the achievement of the final ranking, the weighted average, obtained as follows, shall be taken into account:

- 70% of the average obtained during previous studies at UAB;
- 30% other scientific activities – mobility programs, student circles, competitions, scientific events and other actions and events organized by UAB – (2 points for each activity, but not more than 10 points).

(6) The scholarships shall be awarded by the ME in descending order of the averages, selecting the first applications from each university, within the limit of the number of grants available and taking into account a balanced distribution by universities and, within them, by fields of study.

(7) If two candidates have the same average, the tie-breaker will be made according to the cycle of studies, the priority being, in order, the candidate from the cycle of doctoral studies, master's and, finally, bachelor's degree.

(8) The candidates thus selected shall become beneficiaries of the grants by order of the Minister of Education. The final results of the selection will be communicated to UAB and published on the official website of the ME.

(9) The change of the financial regime of the selected students will be made by the secretariats of the faculties based on the order issued by the Ministry of Education, in the specified bachelor's/master's fields.

(10) In the case of foreign citizens from third countries of the European Union, who do not fall into the category of Romanians abroad and/or have dual citizenship (Romanian and of another state) may benefit from study places from the budget of the Ministry of Education for foreign citizens, in the 2026-2027 academic year. In order to obtain these study grants, candidates selected by state higher education institutions must meet the following conditions:

- a) Study/are admitted to places with fee in foreign currency, in the first year of studies, to bachelor's, master's or doctoral university studies, in the 2026-2027 academic year;
- b) They are graduates of high school/bachelor's/master's degree in an educational institution abroad and have obtained a minimum average of 9.00;
- c) They are graduates of a university study program in Romania, as scholarship holders of the Romanian state, full-time form of education, in Romanian, they have obtained an overall average of at least 8.50 and continue their studies in an accredited state higher education institution in Romania.

Each state higher education institution in Romania will submit a maximum of 5 selected application files to the Ministry of Education, General Directorate for International Relations and European Affairs, by October 1, 2026 at the latest, at the e-mail address international@edu.gov.ro, as follows:

- a) The official address of UAB to the Ministry of Education, nominating the persons proposed to receive a study grant without paying tuition fees, but with a scholarship from the budget of the Ministry of Education; The address will be accompanied by the centralizer containing the ranking of the candidates, in descending order of the results of the selection process, by study cycles;

The application file will contain the following documents: i) copy of the passport; ii) copy of the birth certificate; iii) copy of the diploma of completion of pre-university studies and the transcripts related to the years of study for upper secondary education; iv) the copy of the bachelor's degree and the diploma supplement (transcript) or the certificate showing the academic situation for all years of study, as well as the marks obtained in the bachelor's exam (for graduates of the current

year) for candidates applying to continue their master's studies; v) a copy of the master's degree and the diploma supplement (transcript) or the certificate showing the school situation for all years of study for candidates applying to continue their doctoral studies, as the case may be. The General Directorate for International Relations and European Affairs will analyze the submitted files and will propose the granting of study grants based on the selection criteria, approved by the management of the Ministry of Education. The Ministry of Education will communicate to higher education institutions the final list of candidates who will benefit from study places without paying tuition fees, but with a scholarship from the budget of the Ministry of Education.

Art. 11. (1) Starting with the 2025-2026 academic year, in accordance with the UAB internationalization strategy for the period 2025-2029, the **UAB Scholarship** Program is established, in accordance with the provisions of the Higher Education Law no. 199/2023, as subsequently amended and supplemented.

(2) For each of the specializations in English, from the educational portfolio of UAB, 10 scholarships will be awarded, depending on the annual budget available. The number of scholarships awarded can be redistributed among the specializations in English, depending on the number of candidates enrolled in studies for each of them, after completing the admission process.

(3) The procedure for admission to studies is the one provided for in Articles 13-17 of these Regulations, UAB scholarships being awarded in descending order of admission averages, for university studies in English, within UAB, on places with fee in foreign currency.

Art. 12. (1) The beneficiaries of the **UAB Scholarship** Program have the following rights:

1. the granting of an annual scholarship, equivalent to the tuition fee for the current academic year;
2. financing accommodation expenses in student dormitories;
3. a monthly scholarship in the amount of 1000 lei, in compliance with the legal provisions in force.

(2) and obligations:

1. payment of the annual tuition fee, within 5 days from receiving the scholarship from UAB;
2. obtaining a minimum of 60 credits in each academic year;
3. obtaining a weighted average for the completed academic year of at least 8.00;

(3) Students who have not obtained, at the end of the academic year, a number of 60 credits and a weighted average of at least 8.00, no longer benefit from the scholarship granted, from the financing of accommodation expenses in student dormitories, having the obligation to pay study fees and accommodation expenses in student dormitories starting with the following academic year and until the completion of university studies.

Art. 13. (1) Foreign citizens who cumulatively meet the following conditions are entitled to participate in admission to studies on places with payment of tuition fees in foreign currency:

- a) they are graduates with a baccalaureate, bachelor's, master's degree or their equivalent, as the case may be, and meet the conditions for admission to university studies in their country of origin;
- b) by exception to letter a), holders of long-term higher education diplomas who, according to the legislation of the country of origin, have the right to enroll in doctoral studies without the obligation to complete the second cycle of master's degree studies may enjoy, with the agreement of the receiving universities, the rights conferred in the state of origin;
- c) hold a passport valid for at least 6 months from the start of the study program to which they are applying;
- d) no restrictive measures have been taken on them by the Romanian authorities, by European or international institutions.

(2) Admission to university studies, including for the preparatory year of Romanian language, shall be made on the basis of the following admission criteria:

a. the admission average calculated as the weighted average between:

1. The average obtained at the graduation exam that allows the candidate access to university studies in the cycle for which he/she is applying (30%);

2. The grade obtained in the motivational interview test, based on a letter of intent (70%).

b. the candidates' option mentioned in the online registration form;

The admission average must be equivalent to the average of 5, for bachelor's degree programs, respectively 6 for master's and doctoral programs, in the Romanian education system.

Art. 14. (1) Participation in the admission process for study programs in which the educational process is carried out in Romanian is conditioned by proof of knowledge of the Romanian language according to the provisions of para. (2).

(2) The knowledge of the Romanian language, in order to participate in the admission process for study programs taught in Romanian, can be proven by:

a) presentation of the certificate of graduation of the preparatory year program;

b) presentation of Romanian study documents (diplomas and certificates) or study documents, school situations attesting to at least three years of consecutive studies followed, in Romanian, in a school unit or higher education institution in the national system in Romania;

c) presentation of the Certificate or Attestation of language proficiency minimum level B1, according to the Common European Framework of Reference for Foreign Languages, issued by the higher education institutions in Romania that have accredited the preparatory year program of the Romanian language for foreign citizens, by the pre-university education units accredited for the Romanian language initiation course, the Institute of the Romanian Language or by the Romanian Cultural Institute.

Art. 15. Participation in the admission process for study programs in which the education process is carried out in foreign languages (including the preparatory year of Romanian language) is conditioned by the fulfillment of the criteria established by the UAB, namely obtaining the certificate of language proficiency from the Department of Letters of the Faculty of History, Letters and Educational Sciences. The exam for obtaining the certificate of language proficiency is organized by the Department of Letters of UAB and takes place at least 24 hours before the motivational interview.

Art. 16. The application file of the mentioned foreign citizens contains the following documents:

a) birth certificate - copy and translation;

b) copy of the document attesting to the permanent residence abroad;

c) copy of your passport;

d) Application for the issuance of the letter of acceptance to studies, provided in ANNEX 2, which is an integral part of this regulation, completed in all sections;

e) certified copy and translation of the baccalaureate diploma or its equivalent, authenticated by the competent authorities of the issuing country;

f) copy and legalized translation of the certificate attesting to the passing of the baccalaureate exam for the graduates of the current year; certified copy and translation of the bachelor's degree or its equivalent, authenticated by the competent authorities of the issuing country (as applicable); certified copy and translation of the master's degree or its equivalent, authenticated by the competent authorities of the issuing country (as the case may be);

g) transcripts - copies and legalized translations, related to the studies carried out;

- h) the certificate of graduation of the year of Romanian language or the certificate of language proficiency, as the case may be;
- i) the medical certificate (in an international language) attesting that the person to enroll in the studies is clinically healthy and does not suffer from contagious diseases, or other conditions incompatible with the future profession and at the same time mentioning the personal history related to chronic diseases.

Art. 17. The admission procedure is carried out as follows:

- a) the application files prepared according to art. 16 are submitted/uploaded on the <https://intladm.uab.ro> platform, between 01.02.2026 - 12.07.2026 (in exceptional situations and with the approval of the UAB Board of Directors, the CRI may organize an autumn admission session, during the month of September);
- b) The UAB International Relations Center evaluates the files, according to the legal regulations in force, and draws up the list of persons proposed to take the exams for admission to studies;
- c) The tests for the language proficiency exam and the motivational interview will be organized by the Department of Letters, respectively by the competition commissions, appointed by decision of the UAB rector, with the approval of the Board of Directors. The tests will be held online, using the platforms decided by the competition commissions.
- d) The UAB International Relations Center draws up the list of admitted candidates and communicates it to the ME – DGRIAE in compliance with the provisions regarding the capacity and enrollment figure;
- e) The list shall be accompanied by an electronic copy of the candidate's file drawn up in accordance with art. 16. The electronic copy of the file will be made available to the ME through platforms or other online means managed by UAB or through a portable storage medium;
- f) After analyzing the file, the Ministry of Internal Affairs issues the letter of acceptance to study in Romania;
- g) The ME sends the letters of acceptance to the UAB;
- h) Incomplete files will not be processed, being declared rejected, candidates being notified through the admission platform.
- i) After completing the admission stages, at the signing of the study contract, international students will be enrolled in the Smart UMS application by the CRI staff, under the coordination of the IT department, being assigned the necessary rights for this process;
- j) The files of international students submitted to the secretariats of the faculties shall contain both originals and copies of the documents provided for in art. 16.

Art. 18. The number of places with tuition fee in foreign currency for admission to bachelor's, master's and doctoral studies are provided in ANNEX 1.

Art. 19. (1) In order to process the files for admission to bachelor's, master's and doctoral university studies, including enrollment, the foreign citizen candidates on their own exchange must pay an administrative fee of 150 euros (50 euros representing the equivalent value of the exam and the certificate of linguistic proficiency), which is paid at the submission of the files. This fee cannot be refunded to candidates whose files have been validated on the <https://intladm.uab.ro> platform, even if they do not participate in the language proficiency exam or the motivational interview, being a fee for administering the application files within the admission process.

(2) The tuition fees, for students enrolled with the payment of fees in foreign currency, are established annually by the UAB Senate.

Art. 20. At UAB, admission to doctoral studies is carried out in accordance with the IOSUD regulations and during the periods provided for this purpose.

Art. 21. Enrollment in university studies is conditional on passing the admission contest and is done on the basis of:

- a) ME Order of Acceptance to Studies, for students enrolled in places without payment of tuition fees with scholarship and places without payment of tuition fees but without scholarship;
- b) Letters of acceptance for studies issued by the Ministry of Education for students enrolled in the regime with the payment of tuition fees in foreign currency;
- c) Letters of acceptance to studies issued by ME for UAB Scholarship students.

Art. 22. The enrollment of foreign citizens will be carried out by decision of the rector, until the last day of the first semester, provided for in the structure of the academic year for which the acceptance letters were issued.

Art. 23. (1) Upon enrollment, candidates will present the study and identity documents from the application file, in original, together with the letter of acceptance to studies and the passport with a valid visa for "studies" purposes.

2. Original study documents issued in States that are parties to the Hague Apostille Convention shall be endorsed by the competent authorities of the issuing countries with the Hague Apostille.

(3) Original study documents issued in states that are not parties to the Hague Apostille Convention shall be super-legalized by the Ministry of Foreign Affairs of the issuing country and by the Romanian embassy/consular office in that country.

Art. 24. Upon enrollment, in the school documents (matriculation records, school statements, etc.) the names of foreign citizens will be inscribed according to the data in the passport. The same name will also be written on the documents issued at the end of the studies (diploma, diploma supplement).

Art. 25. Upon enrollment, the Study Agreement will be concluded between UAB and the student. The model of the study contract will be approved annually by the University Senate. The study contract is concluded in Romanian, and upon request, an unofficial version in English can be made available.

Art. 26. After enrollment, foreign citizens are registered in the matriculation register with a unique number valid for the entire period of schooling at the specialization/study program to which they were admitted.

Art. 27. Foreign citizens who acquire Romanian citizenship can occupy a place of study financed from the state budget or in a fee regime, at the amount established by the university senate for Romanian citizens, provided that they pass the admission contest organized in a legally established session, according to UAB's own regulations.

Art. 28. The letter of acceptance is valid only for the higher education institution for which it was issued, starting with the academic year for which it was issued and for the respective university cycle. Any change in the academic path, which is contrary to the documents in the initial acceptance letter, will be regulated, at the request of the educational institution involved, by the issuance by the Ministry of Education of a new acceptance letter.

Art. 29. Enrollment in studies, academic mobility, temporary or permanent, change of field of study and re-enrollment are carried out exclusively with the approval of the Ministry of Education.

Art. 30. Foreign citizens have the following obligations:

- a) to respect the Romanian Constitution and the laws of the Romanian state;
- b) to comply with the internal regulations of the educational institution in which they work;
- c) to comply with the provisions of these Regulations and the internal acts of UAB;
- d) to notify the University or the competent authorities if they have obtained the visa to study in Romania. If he/she does not show up for enrollment by the deadline provided for in Article 22, the refund of the tuition fees paid in order to obtain the study visa shall be made only to citizens, candidates from third countries, who prove that they have not used the visa for purposes other than entering the territory of Romania for enrollment in the UAB.

ANNEX 4 (A-E) – CRITERIA FOR EVALUATING CANDIDATES IN THE MOTIVATIONAL INTERVIEW

Art. 32. (1) This Regulation shall enter into force on the date of its adoption by the Decision of the Senate.

(2) The amendment of this Regulation may be made by the Decision of the Senate.

In carrying out the activities subject to this Regulation, the European regulations imposed by Regulation no. 679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, as well as those provided by the internal regulations developed within the "1 Decembrie 1918" University of Alba Iulia and other relevant provisions in the field.
